Syllabus Change Overview

- Version 1 of the Certificate in ESG Investing syllabus is valid for testing between 2
 September 2019 31 August 2020.
- Version 2 of the Certificate in ESG Investing syllabus is valid for testing from 1 September 2020 30 September 2021.

General changes in overview are as follow:

- Changes to the order of some syllabus topics have been made to enhance the logical flow of learning
- Changes to the order of some syllabus learning outcomes have been made to enhance the logical flow of learning
- A small number of learning outcomes have been deleted (Version 1 LOs 2.1.4, 2.1.7, 6.1.16, 7.1.2; coverage was already included in other learning outcomes or has been moved to sit in other learning outcomes)
- A small number of new learning outcomes have been included (Version 2 LOs 1.1.1, 3.1.1, 3.1.8, 4.1.3, 6.1.2, 9.1.5)
- Minor changes to a small number of learning outcomes have been made
- Substantial changes to a very small number of learning outcomes have been made (Version 1 LOs 1.1.5, 4.1.4, 6.1.13, 7.1.14)

There have been no changes to the Topic Question Allocations

Please note: although many of the learning outcomes have remained unchanged, the learning materials have been updated across the syllabus. In particular, Chapters 1, 2 and 8 have been rewritten.
