Improving ethical behaviour in the investment profession

The CFA UK Ethical Leadership Programme is run using Duke Corporate Education's tried and tested philosophy of 'learning by doing', whereby participants can act their way into a new way of thinking and doing. Complex scenarios are presented for examination, analysed and then worked through. These situations are reviewed within and across groups, with input from current leaders in the investment profession.

The culture of an investment firm is important to its stakeholders, clients and to the regulators. It also influences a firm's ability to attract and retain leading investment professionals. The way that a firm addresses ethical issues – how these are identified, managed and understood – is a major cultural indicator and can have a direct impact on the bottom line.

This is a unique opportunity for current and future leaders of the investment profession to work together to build ethical competencies and enhance the profession's capacity to serve its stakeholders.

Programme structure

The design offers three critical integrating themes around which the programme is structured:

- Understanding, practising and 'pressure testing' critical ethical leadership qualities and skills
- Building relationships to generate a strong, problem-solving alumni as an enduring resource for the profession
- Understanding how to share the learned ethical skills to the benefit of participants' firms

Programme summary

The programme will help participants understand their individual and collective orthodoxies, challenge their behaviours, and establish a new set of skills and practices. The programme will create a powerful alumni network of ethically skilled and aware leaders to sustain and develop the profession into the future. As participants explore themes together, the common understanding which emerges will reinforce the foundation for best practice in ethics across the investment profession.

Educational Training ethos

- Designed for leaders of the future, who care about improving and implementing ethical principles





Participant criteria

- Up to two participants from each investment firm
- Priority given to firms who participated in the inaugural programme. Participants do not need to be CFA UK members
- Participants to be investment professionals with over 15 years' experience who have been identified as leaders or potential leaders within their firms
- Typical job titles would include: Deputy Cl0, Head of Investment, Desk Head or Head of Product Development
