FEES:

All payments shall be remitted by applicant/sponsor free and clear of any withholdings or deductions for any and all future taxes. Applicant/sponsor shall be responsible for the remittance of any such withholdings or deductions, as well as for payment of any transfer duty, tax, or administrative processing fee.

Upon request, applicant/sponsor will provide evidence to CFA UK that all such payments have been made.

Following registration an invoice will be issued for full payment to be paid within 14 days.

Only the nominated person may attend any day of the programme without permission of CFA UK.

There is a right of cancellation up to 14 days post signature of the form.

CANCELLATION:

On registration the firm is taking responsibility for their place on the programme and, hence, if the nominated person cannot then attend for whatever reason, it is the firm's responsibility to replace the participant.

If a cancellation request is received in writing (e-mail is preferred), and there is a waiting list for the programme, then all fees will be passed to the firm on the waiting list wishing to take up the place and the original booking will be reimbursed. Otherwise no fees will be returned due to significant advance programme preparation and costs.

Please note that CFA UK reserves the right to postpone or cancel a programme due to lack of demand. Based on current cost estimates, CFA UK requires 20 delegates on the programme in order to proceed.
